Application forms for each main category for the registration could be obtained in English & Sinhala Language open written request on supplier’s letter head with the Main Category & Sub Category you wish to register and on a cash payment of non- refundable document fee of **Rs. 1000/=** from the **Manager (Purchasing & Shipping), State Timber Corporation, “Sampathpaya”, No: 82, Rajamalwatta Road, Battaramulla.** Between **09.00hrs to 12.00hrs and from 13.00hrs to 15.00hrs Cheques/ Money orders and Postal orders will not be accepted.**
- D. Suppliers of outside Colombo district can register at our regional office by paying a non-refundable document fee of Rs.1000/= per each main category & collect relevant documents from the Regional Manager.
- E. Quotations for Supplies/Services will be called from the List of registered suppliers, but the State Timber Corporation reserves the right to select suppliers to call for quotations even outside the Registered List, in view of obtaining competitive offers.
- F. Suppliers and Contractors who are registered with the corporation for 2025 are requested to send fresh applications for year 2026.
