Applications downloaded from the link www.timco.lk → **important Notices** → **Registration 2024** (Download Application Form) should be forwarded under registered post marked “**Registration of Suppliers for Year 2024**” on the top left hand corner of the envelope or hand delivered to reach the Manager (Purchasing & Shipping),State Timber Corporation,”Sampathpaya”,82,Rajamalwatte Road, Battaramulla on or before **15.00 hrs on 25.11.2023**.
- D. Suppliers of outside Colombo district can register at our regional office by paying a non-refundable document fee of Rs.500/= per each main category & collect relevant documents from the Regional Manager.
- E. Quotations for Supplies/Services will normally be called from the List of registered suppliers, but the State Timber Corporation reserves the right to select suppliers to call for quotations even outside the Registered List, in view of obtaining competitive offers.
