# Selection of a Consultancy firm for preparation of the Corporate/ Strategic Plan of State Timber Corporation 2022 – 2026

#### A. Introduction

The State Timber Corporation was incorporated in 1968 by Hon. Minister of Lands, Irrigation and Power under the provisions of State Industrial Corporation Act No. 49 of 1957 and thereafter by the Gazette Notifications of No.178/10 of 05.02.1982 and Gazette No.1190/7 of 26.06.2001 and Gazette No. 1538/7 of 25.02.2008. The initial capital of the Corporation was Rs.2.5 million. Head office is situated in Sri Jayewardenepura.

During the very first 03 years after its establishment, the Corporation has been able to achieve an income of Rs.24.5 million, a gross profit of Rs.11 million and a net profit of Rs.1.9 million, by proving the efficiency of handling the business. In addition to the financial performances, Corporation has been able to expand its network up to 61 depots, 07 Regional Offices with a total work-force of 1,537 numbers of employees.

1970 - 1980 time period was a remarkable time period to STC. By 1977 it had 12 saw mills in operation. In 1980 the STC made history being the first State Corporation to initiate its accounting functions using computer technology. In 1989 the Corporation relocated its head office in a new building 'Sampathpaya' in Battaramulla and was able to carry out its administrative functions in a more efficient manner.

With the experience gained over the past 50 years & the capabilities State Timber Corporation has become the nation's leader in providing most trusted and best quality timber and timber based products in Sri Lanka.

At the present, State Timber Corporation has 12 regional offices, 54 sales outlets, more than 200 working coupes to harvest timber from the forest plantations and 03 furniture manufacturing factories including impregnation & seasoning plants & 12 showrooms.

The State Timber Corporation employs around 2,178 people in both its Head Office and Regional Offices Island wide.

The Functions of the State Timber Corporation are given as follows;

- 1. Extraction of Timber from State Forests, conversion of such timber into sawn timber and finished products, sale of logs, sawn timber and finished products and construction of forest roads required for the above purpose.
- 2. Acquisition, construction and operation of logging units, sawmills, impregnation and preservation plants, seasoning and drying kilns and other necessary equipment and installations.
- 3. Operation of timber and firewood sales depots
- 4. Manufacture and marketing of any by products from timber
- 5. Afforestation, reforestation and scientific management of forests and forest plantations.
- 6. Agricultural production
- 7. Export of timber related finished and semi-finished products.
- 8. Purchase of forest related products.
- 9. Processing of forest related products.
- 10. Import of cane
- 11. Identification and Classification of Local and imported timber species through sample testing.
- 12. Conduct Training Programs on Timber Industry Related subjects and issue certificate and undertake Environmental Awareness Programs to contribute toward developing and Environmental Conscious Society.
- 13. Planning and making investments so as to optimize the return from the lands and buildings owned by the corporation

#### **B.** Objective of the Assignment

The purpose of this assignment is to prepare a five year corporate/Strategic plan to ensure that the State Timber Corporation fulfills its mandate.

The plan will provide long term planning guidelines, assign priorities, and suggest practical strategies to ensure efficiency & effectiveness functioning of State Timber Corporation.

#### C. Scope of the assignment

The scope of service provided by the consulting firm should include the following:

- Strategic directions of the corporation for 10 years including Purpose, vision, Mission & goals
- II. Corporate/Strategic plan for 2022 – 2026
- III. Business plan for 2022 - 2026

IV. Detailed action plan for one year period -2022 by reviewing the existing set up and processes, activities, sub activities and other management procedures to achieve organizational goals.

#### V. SWOT Analysis

- Assess and analyze Corporation's internal environment/ context (mission, vision, policies, processes, activities, sub activities etc.)
- Assess and analyze external environment and stakeholders
- VI. Draft and finalize corporation's corporate/Strategic plan with the concurrence of STC top management.

#### VII. Present to STC management

#### D. Methodology

The Consultant will be required the analysis of where it is and where it needs to be with the overall direction of focusing 10 years ahead for the State Timber Corporation making it sustainable, efficient and growth oriented in the long run. The plan should be time bound and show clear achievable targets.

Preparation of the corporate/Strategic plan expected to be carried with workshops, Interviews & site visits with STC officials with brainstorming sessions and develop it in collaboration with STC top management.

Draft corporate/Strategic plan should be finalized including the strategic plan, business plan & the action plan and referred to STC top management for final review.

Required Facilities / amenities can be provided to have workshops, interviews & site visit by the STC.

The firm should be Present the finalized Corporate/Strategic plan to the Board of Directors & also commissioning of the plan to be done by the consultant.
