- Duly perfected bids in duplicate in separate covers marked **“Original”** and **“Duplicate”** re-inserted in a single cover mentioning the name of work on the top left hand corner of all three envelopes, Sealed and may either by sent by registered post addressed to **Chairman, Procurement committee, State Timber Corporation, 82, Rajamalwatta Road, Battaramulla** or deposited in the Tender Box kept in the at Head Office to reach at or before **10.30 a.m.** on **19.01.2024**. Late bids will be rejected. Bids will be opened soon after closing, in the presence of the bidders or their representatives.

4. All bids should be accompanied by a bid security obtained from a reputed bank operating in Sri Lanka or Recognized Insurance Company or from the Construction Guarantee Fund (CGF). Bid security valid for a period given in the above table from the date of close of bids. The Bid security should be **“On-demand & Un-conditional”** and on the format given in the Bidding Document. All applications outside the prescribed format will be rejected.
5. According to Public Finance Circular No. 04/2016 (iv) dated 09.02.2023 the evaluation will be done on the basis of its reference in the financial evaluation of the bid.
