The Top left hand corner of the cover should be marked "Registration of Suppliers for the supply of Non Wooden & Wooden furniture for the year 2021".

Application forms for each main Item for registration could be obtained in English Language **upon written request on supplier's letter head** and on a cash payment of non refundable document fee of Rs.500/= from the Deputy General Manager (Marketing), State Timber Corporation Marketing Division, "Sampathpaya", 82, Rajamalwatte Road, Battaramulla **between 09.00hrs. to 12.00hrs. and from 13.00hrs. to 15.00hrs.** Cheques/Money orders and postal orders will not be accepted.
