Duly perfected bids in duplicate in separate covers marked "Original" and "Duplicate" re-inserted in a single cover mentioning the name of work on the top left hand corner of all three envelopes, Sealed and may either be sent by registered post addressed to "Chairman, State Timber Corporation, 82, Rajamalwatta Road, Battaramulla or deposited in the Tender Box kept in the Chairman's Office to reach at or before 10.30 a.m. on 28.12.2021 late bids will be rejected. Bids will be opened soon after closing, in the presence of the bidders or their representatives.
5. All bids should be accompanied by a bid security obtained from a reputed bank operating in Sri Lanka or from the Construction Guarantee Fund. Bid security valid for a period given in the above table from the date of close of bids. The Bid security should be "On-Demand & Un-Conditional" and on the format given in the Biding Document. All applications outside the prescribed format will be rejected.
6. According to Public Finance Circular No. 03/2020 (i) dated 11.01.2021 the evaluation will be done on the basis of its reference in the financial evaluation of the bid.
